1 st PRE-REGISTRATION PHASE

PRE-REGISTRATION	From 12 July to 4 November 2024	The deadline to complete the minimum documentation for access will be 10 natural days from pre-registration or until 4 November 2024. The month of August shall not be considered for academic purposes and no new pre-registrations will be able to be done. Candidates pre-registered in July will have access to the document manager to upload documentation, which will be checked from September.		
ADMISSION	From 12 July to 4 December 2024	Periodically, the coordination will admit on academic grounds candidates depending on the number of people pre-registered who have submitted the minimum documentation. Admission on academic grounds involves reservation of the place for the same academic year in which pre-registration has been done. The month of August shall not be considered for academic purposes and admissions done in August will be managed from September.		
REGISTRATION	From 4 October to 19 December 2024	Candidates admitted in this phase who have not registered within this period may still do it beyond the deadline paying the corresponding fees. The final deadline to register for candidates pre-registered in this phase is 10 April 2025.

Admission on academic grounds involves reservation of the place for the same academic year in which pre-registration has been done.		
REGISTRATION	From 13 January to 10 April 2025	Candidates admitted in this phase who have not registered within this period may still do it beyond the deadline paying the corresponding fees. The final deadline to register for candidates pre-registered in this phase is 13 June 2025. If registration is done after 30 April 2025, the student will only be able to attend the 2 nd evaluation call (June).

Doctoral students of second academic year and subsequent who have been favourably evaluated in April or June, who have been authorised to submit the thesis after 5 September 2024 and always in compliance with the deadlines and additional requirements for the thesis submission established by the academic committee of the doctoral programme. 		
	From 14 to 25 October 2024	Doctoral students registered as new students for the academic year 2023-24, who were pre-registered during the 3 rd phase and who have been favourably evaluated on the 2 nd evaluation call (September), who have been authorised to submit the thesis after 5 September 2024 and always in compliance with the deadlines and additional requirements established by the academic committee of the doctoral programme.		
	Doctoral students of second academic year and subsequent who have not registered within the corresponding period may still do it beyond the deadline but they will be required to pay the corresponding additional fees. The final registration deadline is 10 April 2025.
